

FEE RESOLUTION

A resolution establishing fees for the filing of applications, permits and licenses
for the Township of Pulaski

WHEREAS, the Board of Supervisors of the Township has adopted a codification, consolidation and revision of the ordinances of the Township; and

WHEREAS, it is the desire of the Board of Supervisors of the Township to eliminate all filing fees, permit fees and license fees from the Code of Ordinances and enact them instead by resolution.

NOW, THEREFORE BE IT RESOLVED THAT and it is hereby resolved by the Board of Supervisors of the Township that all fees are hereby fixed as follows:

CODE ENFORCEMENT

Building Permit Fees

The cost of a building permit shall be as follows

Occupancy Dwelling. Minimum fee of \$20.00 per structure plus \$2.00 per \$1,000.00 or part thereof over the first \$1,000.00

Swimming Pools. Minimum fee of \$20.00 plus \$2.00 per \$1,000.00 or part thereof over the first \$1,000.00

Fences. Fee of \$20.00

Driveways. (New access) Fee of \$20.00

Copy of estimate from contractor or bills from building supplies used in the work. Diagram of the lot with existing structures and proposed additions, designated by broken lines, as well as lot dimensions and building dimensions.

Building Permit

\$0.00 to \$200.00

\$201.00 to \$1,000.00

Each additional \$1,000.00 or part thereof beyond the first \$1,000.00

ATTORNEY'S FEES ON MUNICIPAL CLAIMS

Preparation and filing of each claim.	\$175.00
Preparation and mailing of a written notice of claim filing to the property owner	\$25.00
Preparation and filing of a suggestion of nonpayment and averment of default to revive and continue in effect the lien of a previously filed claim.	\$100.00
Preparation of a Praeceptum for satisfaction of a claim in lien and the mailing thereof to the property owner for filing.	\$50.00
Preparation of a Praeceptum for issuance of a writ of scire facias.	\$150.00
Professional services of the Township's attorney in all proceedings (including, but not limited to, trial) and held upon a writ of scire facias.	\$125.00
