PART 1

SOLID WASTE FLOW CONTROL

§20-101. Definitions.

Unless the context clearly indicates otherwise, the following terms used in this Part shall have the following meanings:

ACT 101 - the Municipal Waste Planning, Recycling and Waste Reduction Act. Act of July 28, 1988, P.L. 528, No. 101, as now or hereafter amended.

DISPOSAL - the deposition, injection, dumping, spilling, leaking or placing of solid waste into or on the land or water in a manner that the solid waste or a constituent of the solid waste enters the environment, is emitted into the air or is discharged to the waters of the Commonwealth of Pennsylvania.

LANDFILL - a facility using land for disposing of municipal waste. The facility includes land affected during the lifetime of operations including, but not limited to areas where disposal of processing activities actually occur, support facilities, borrow areas, offices, equipment sheds, air and water pollution control and treatment systems, access roads and transportation and storage facilities. The term does not include construction/demolition waste landfills or a facility for the land application of sewage sludge.

MUNICIPAL WASTE - any garbage, refuse, industrial lunchroom or office waste and other material, including solid, liquid, semisolid or contained gaseous material resulting from operation of a residential, municipal, commercial or institutional establishments and from community activities and any sludge not meeting the definition of residual or hazardous waste in the Solid Waste Management Act from a municipal, commercial or institutional water supply treatment plant, wastewater treatment plant or air pollution control facility. The term does not include source-separated recyclable materials.

MUNICIPAL WASTE LANDFILL - any facility that is designed, operated or maintained for the disposal of municipal waste, whether or not such facility possesses a permit from the Department under the Solid Waste Management Act. The term shall not include any facility that is used exclusively for disposal of construction/demolition waste or sludge from sewage treatment plants or water supply treatment plants.

MUNICIPALITY - any city, borough, incorporated town, township or home rule municipality located in the County.

PERMIT - permit number issued by the Department for the operation of the landfill by operator.

SOLID WASTE

PERSON - any individual, partnership, corporation, association, institution, cooperative enterprise, municipality, municipal authority, Federal Government or agency, State institution or agency or any other legal entity whatsoever which is recognized by law as the subject of rights and duties.

RECYCLING - the collection, separation, recovery and sale or refuse of metals, glass, paper, leaf waste, plastics and other materials which would otherwise be disposed or processed as municipal waste or the mechanized separation and treatment of municipal waste (other than through combustion) and creation and recovery of reusable materials other than a fuel for the operation of energy.

SOLID WASTE MANAGEMENT ACT - Act 97 of 1980, 35 P.S. §60818.101 *et seq.*, and the Department regulations promulgated thereunder.

§20-102. Licensing of Collectors and/or Transporters.

Not later than 120 days after the effective date of County Ordinance No. _____, all persons collecting and or transporting waste within the Township shall be required to obtain a County license pursuant to County Ordinance No. _____.

§20-103. Disposal of Township Waste at Designated Township Waste Processing or Disposal Facility.

All Township waste collectors and transporters shall deliver and dispose of all Township waste generated within the Township, other than recyclable materials as designated in this Part, at the site(s) designated by the Township. Township of Pulaski has contracted for waste disposal capacity with various landfills approved by Beaver County, Pennsylvania, for a period of 5 years with the option to renew said contract for an additional 5 years.

§20-104. Regulations.

All collectors and transporters shall comply with all County rules and regulations adopted by the County and this Township pursuant to Act 101, County Ordinance No. _____ or this Part.
