JOINT RESOLUTION DISSOLVING THE
NEW BRIGHTON AREA RECREATION BOARD

A JOINT RESOLUTION OF THE BOROUGH OF NEW
BRIGHTON, THE TOWNSHIP OF DAUGHERTY, THE
TOWNSHIP OF PULASKI AND THE NEW BRIGHTON
AREA RECREATION BOARD THAT OPERATED THE
SUNRISE POOL FROM 1971 TO 2008.

WHEREAS on June 14, 1959 the Borough of New Brighton, the Township of Daugherty, the Township of Pulaski and the Borough of Fallston (Fallston later withdrew from the Authority) formed the New Brighton Area Recreation Authority, pursuant to the Municipal Authorities Act of 1945, and

WHEREAS on August 19, 1969 a forty (40) year Lease Agreement was executed between the New Brighton Area School Authority and the New Brighton Area Recreation Authority to fund, construct and lease a swimming pool at the high school complex which was named Sunrise Pool, and

WHEREAS on December 1, 1971 Articles of Amendment were executed between the following parties: The New Brighton Area Recreation Authority, the New Brighton Area School Authority, the New Brighton Area School District, the Borough of New Brighton, the Township of Daugherty and the Township of Pulaski establishing the New Brighton Area Recreation Board (aka the New Brighton Recreation Board) to operate the Sunrise Pool, and

WHEREAS on December 31, 1971 Articles of Agreement were executed between the New Brighton Area Recreation Authority and the New Brighton Area School Authority, the New Brighton Area School District, the Borough of New Brighton, the Township of Daugherty and the Township of Pulaski that provided for debt service payments on Sunrise Pool, and

WHEREAS on August 19, 2009 the debt service having been previously retire, the forty (40) year lease on the Sunrise Pool expired without renewal by the parties and pursuant to the terms of the lease, ownership of Sunrise Pool reverted to the New Brighton Area School District, and

WHEREAS all other terms and conditions of the above described agreements have been fulfilled by the parties and no other purpose exists for the existence of the recreation Board, and

WHEREAS the New Brighton Area School District has elected to reopen Sunrise Pool under the sole ownership, maintenance, control and direction of the school district.

NOW THEREFORE BE IT RESOLVED, by the Borough Council of the Borough of New Brighton, the Board of Supervisors of the Township of Daugherty, the Board of Supervisors of the Township of Pulaski and the School Board of the New Brighton Area School District, all of Beaver County, Pennsylvania, that the parties do hereby agree (the New Brighton Area Recreation Authority and the New Brighton Area School Authority having become inactive) that by this joint resolution the New Brighton Area Recreation Board is hereby dissolved and shall cease to exist.
