

**PULASKI TOWNSHIP**  
**REGULAR MEETING**  
December 12, 2022

The Pulaski Township Supervisors monthly meeting was held on Monday, December 12, 2022 in the Pulaski Township Fire Hall, 3401 Sunflower Road, New Brighton, PA 15066. The meeting was called to order at 6:00 PM by Chairman, Casey Zachodni. Mr. Zachodni led the ledge to the flag.

Those in attendance were Casey Zachodni, Ralph Flara, Mark Wagle, Chief Ron Walton, Attorney Joseph M. Budicak, Bill Thomas, Deb Hickman, and Connie Wagle.

A motion was made by Mr. Zachodni and seconded by Mr. Wagle to approve the minutes from November 14, 2022. Vote on the motion: Mr. Zachodni – yes, Mr. Flara – yes, Mr. Wagle – yes. The motion is carried.

A motion was made by Mr. Zachodni and seconded by Mr. Flara to approve the Treasurers' report for November 2022. Vote on the motion: Mr. Zachodni – yes, Mr. Flara – yes, Mr. Wagle – yes. The motion is carried.

**PUBLIC PARTICIPATION**

Mr. Zachodni would like to make an announcement to start off public participation. He states that there has been a rumor circulating in the township regarding the supervisors possibly going to make a contract with the State Police or Rochester for our police coverage. He states there was never any idea to contact the State Police and there was a call made to Rochester to compare costs, however they are having issues and could not help at this time. Mr. Wagle confirmed this was merely a rumor. Mr. Zachodni states that later in the meeting we will be accepting the contract with New Brighton for police coverage.

Mr. Thomas is inquiring about what is happening with the car wash and what is going on with it? Mr. Zachodni explains that the zoning meeting has been postponed due to one member of the zoning committee had to resign immediately due to personal problems and the supervisors will appoint a new one tonight during the new business and Mrs. Griffith has recent surgery and once she is recovered things will proceed. Chief Walton added a question that once the meeting is done for the variance for parking if the stop sign can be moved closer to Sunflower Road. Attorney Budicak also stated that if the zoning committee okays the variance that the township should probably consider changing the zoning for parking. Mr. Thomas also suggests amending zoning to accommodate parking for any business coming into the township. Mrs. Hickman also asked about when the tractor trailers will be permitted to deliver to the store. Attorney Budicak added we may need to have more than one meeting to clear everything. Mr. Thomas also states that the New Brighton Area Comprehensive Plan meetings are held the first Thursday of every month in the Daugherty Municipal Building at 7:00 PM. He will mention amending the zoning at the next meeting.
