

PULASKI TOWNSHIP
REORGANIZATION MEETING
January 2, 2024

The Pulaski Township Supervisors held their 2024 Reorganization Meeting on January 2, 2024 in the Pulaski Township Fire Hall, 3401 Sunflower Road, New Brighton, PA 15066.
Mr. Casey Zachodni, Chairman called the meeting to order with leading the pledge to the flag.

Those present were Casey Zachodni, Mark Wagle, Connie Wagle.

CHAIRMAN: A motion was made by Mr. Wagle to nominate Mr. Zachodni as Chairman for 2024. Mr. Zachodni abstained from the seconded then seconded it due to the absence of Mr. Flara. Vote on the motion: Mr. Wagle – yes, Mr. Flara – absent, Mr. Zachodni – abstained due to Mr. Flara’s absence and then voted yes. The motion is carried.

VICE CHAIRMAN: A motion was made by Mr. Zachodni to nominate Mr. Wagle as Vice Chairman for 2024. Mr. Wagle abstained from the seconded the seconded it due to the absence of Mr. Flara. Vote on the motion: Mr. Zachodni – yes, Mr. Flara – absent, Mr. Wagle – abstained from vote but due to Mr. Flara’s absence he then voted yes. The motion is carried.

APPOINT SECRETARY/TREASURER: A motion was made by Mr. Zachodni to appoint Connie Wagle as Secretary/Treasurer for 2024 with a salary of \$15,000, office hours will be Monday 9:00 – 2:00, Tuesday 3:00 – 6:00, Thursday 10:00 – 2:00. Sick days and funeral days as needed. Mr. Wagle abstained for the seconded and then seconded it due to the absence of Mr. Flara. Vote on the motion: Mr. Zachodni – yes, Mr. Flara – absence, Mr. Wagle – abstained but due to Mr. Flara’s absence he voted yes. The motion is carried.

APPOINT ROAD FORMAN: A Motion was made by Mr. Wagle to appoint Michael Zachodni as the Road Foreman for 2024 at \$25.00/hour with work schedule at 40 hours per week and 5 sick days and 25 vacation days. Mr. Zachodni abstained from the seconded but then seconded due to absence of Mr. Flara. Vote on the motion: Mr. Wagle – yes, Mr. Flara – absent, Mr. Zachodni abstained from vote but then voted yes due to absence of Mr. Flara. The motion is carried.

SET THE TREASURERS AND TAX COLLECTOR BOND: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to set the treasurers bond at \$150,000.00 for 2024 and set the tax collectors bond at \$200,000.00 for 2024.
Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – absent. The motion is carried.

SET THE PER DIEM FOR MEETINGS: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to set the per diem for meetings as \$100. This took effect this year for newly elected supervisor, the remaining 2 supervisor positions will receive this after each election year respectfully. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

DETERMINE HOLIDAYS FOR EMPLOYEES: (see below). A motion was made by Mr. Zachodni and seconded by Mr. Wagle to approve paid holidays for 2024 for hourly employee(s). Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

APPOINT CPA FOR 2024 AUDIT: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Herrmann & Loll as CPA for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – absent. The motion is carried.

CHAIRMAN OF PUBLIC SAFETY: A motion was made by Mr. Wagle to name Mr. Zachodni as chairman of public safety for 2024. Mr. Zachodni abstained from the seconded and then seconded this due to Mr. Flara’s absence.
Vote on the motion: Mr. Wagle – yes, Mr. Flara – absent, Mr. Zachodni – abstained from vote but due to Mr. Flara’s absence he then voted yes. The motion is carried.

CHAIRMAN OF FINANCE: A motion was made by Mr. Wagle and seconded by Mr. Zachodni to name Mr. Zachodni as Chairman of finance for 2024. Vote on the motion: Mr. Wagle, Mr. Zachodni – yes, Mr. Flara – absent. The motion is carried.

REPRESENTATIVE TO COG: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to name Mr. Wagle as representative to COG for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – absent. The motion is carried.

APPOINT TOWNSHIP SOLICITOR: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Attorney Joseph M Budicak as township solicitor for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – absent. The motion is carried.

APPOINT CODE ENFORCEMENT OFFICER: a motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Mrs. Peggy Griffith as Code Enforcement Officer for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

APPOINT DELINQUENT TAX COLLECTOR: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Judy Hage as the delinquent tax collector for 2024. Vote on the motion:
Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – absent. The motion is carried.

APPOINT LOCAL 511 TOWNSHIP TAX COLLECTOR: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Judy Hage as tax collector for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

APPOINT TOWNSHIP RESIDENT FOR CHAIRMAN OF VACANCY BOARD: A motion was made, Mr. Zachodni and seconded by Mr. Wagle to name Craig Dietz as chairman of vacancy board for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

APPOINT RESIDENTS TO SERVE ON THE ZONING COMMITTEE: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to name Joe Helbling, Jessica McAuley and Matthew Makowiecki to serve on the zoning committee for 2024. Vote on the motion: Mr. Wagle – yes, Mr. Zachodni – yes, Mr. Flara – yes. The motion is carried.

APPOINT RESIDENT REPRESENTATIVES TO SERVE ON THE PLANNING COMMISSION BOARD: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Bill Thomas and Kathy Pavalinch to represent the township on the Planning Commission Board for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.

APPOINT RESIDENT TO SERVE AS REPRESENTATIVE TO THE RECREATION BOARD: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Ralph Flara as representative to the recreation board for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle- yes, Mr. Flara – absent. The motion is carried.

APPOINT ENGINEER: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Lennon & Smith, Sourlet as the engineers for 2024. Vote on the motion: Mr. Wagle – yes, Mr. Zachodni – yes, Mr. Flara – absent. The motion is carried.

APPOINT DELEGATE TO THE STATE ASSOCIATION CONVENTION: A motion was made by Mr. Zachodni and seconded by Mr. Wagle to appoint Mr. Zachodni as delegate to the state association convention for 2024. Vote on the motion: Mr. Zachodni – yes, Mr. Wagle – yes, Mr. Flara – yes. The motion is carried.
